Audit focus can vary from meeting the skilled requirements of therapy, to timely and accurate Medicare certifications with a large emphasis on verifying HIPPS codes generated by PPS MDS.

- Review basic Medicare compliance topics including skilled requirements for rehab and nursing, physician certifications, and daily skilled documentation requirements.
