

LTC Life Safety Code and Emergency Preparedness Regulatory Academy



October 11, 2022

Life Safety Code (LSC) surveys are included in figuring the overall health inspection scores in a nursing home's 5-star quality rating, which means that compliance has not been more important than ever before. Join LeadingAge lowa for LSC and Emergency Preparedness Regulatory Academy on Oct. 11 for a comprehensive program designed to help improve your survey compliance success. In the Life Safety Code and Emergency Preparedness Regulatory Academy, the life safety code K-tags and emergency preparedness E-tags will be reviewed in depth, including examples of deficient practices commonly cited at each tag. Attendees will learn how to comply with the regulations, methods to include monitors in routine quality assurance programs, and receive links to resources that attendees can access including policy and procedure templates and forms that comply with inspection requirements. This training will be provided in a hybrid delivery so that you can choose whether you want to attend in-person or in a live-streaming, virtual format.

The content presented in this LSC and Emergency Preparedness Regulatory Academy is developed based on the material presented on the first day of the Long-Term Care Regulatory Academy. This training is not recommended for those who took the 2022 Long-Term Care Regulatory Academy as there will likely contain some duplication.

- Identify commonly cited K-tags and E-tags, including examples of noncompliance.
- Develop a quality assurance program that monitors requirements in life safety code and emergency preparedness to ensure compliance.
- Incorporate policies and procedures to ensure compliance with life safety code and emergency preparedness requirements.
